BOND RESOLUTION OF THE VILLAGE OF FREEPORT, NEW YORK, ADOPTED DECEMBER 17, 2018, AUTHORIZING ACQUISITION OF GYM EQUIPMENT, STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$50,000, APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE, AND AUTHORIZING THE ISSUANCE OF BONDS OF SAID VILLAGE IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$50,000 TO FINANCE SAID APPROPRIATION

The object or purpose for which the bonds are authorized is the acquisition of gym equipment, at the estimated maximum cost of \$50,000.
